The graphic below illustrates an example of the water tap calculator used by the District to assess water and wastewater system development fees (tap fees) for single-family residences within the Sky Ranch/Lowry Service Area. The tap fee assessment process begins when an application and plot plan for a single-family residence is sent to the District. The application will contain values for Inputs 1-5 and other descriptive information for the property. The values for Inputs 5-7 are prescribed by the District depending on lot size as described in Section 4 of these Rules and Regulations.

TAP FEE EXAMPLE - ATTACHED PRODUCTS (Duplex, Paired, Townhome, etc.)

The graphic below illustrates an example of the water tap calculator used by the District to assess water and wastewater system development fees (tap fees) for attached residences within the Sky Ranch/Lowry Service Area (excludes multifamily). The system development fees for attached products are broken into three portions: indoor water use, outdoor water use (landscaping), and wastewater. The indoor water and wastewater fees are fixed for each unit and the outdoor water use fee is dependent on the size of the lot with a fee rate set at \$4.63/sq. ft. of landscaped area. An example calculation for a system development fee for a paired unit with 700 square feet of landscaped front/back yard is displayed below (excludes meter set fee and service line inspection fee).

TAP FEE CALCULATOR EXAMPLE - IRRIGATION

The graphic below illustrates an example of the water tap calculator used by the District to assess water system development fees (tap fees) for non-residential irrigation systems within the Sky Ranch/Lowry service area. The tap fee assessment process begins when an application and design plans for the irrigation system is sent to the District. The application will contain values describing the area being irrigated, plant types, and other information about the irrigation system. The irrigation tap fee is assessed by multiplying the irrigated area by the tap fee values shown in Appendix E of these Rules and Regulations.
